



OVERVIEW – FEBRUARY 2022

- ASX-listed companies raised A\$391.0m in February 2022.
- Represents a 82% decrease vs February 2021's total of \$2.2b, and a 51% decrease vs January 2022's total of \$809.1m.
- Total of 57 transactions, average size of \$6.86m.
- Total funds raised in February 2022 for energy & minerals was \$316.5m.
- Total of 40 Energy & Minerals transactions, average size of \$7.91m




