



OVERVIEW - JULY 2022

- ASX-listed companies raised A\$4.3b in July 2022.
- Represents an 8% increase vs July 2021's total of \$4.0b, and a 30% increase vs June 2022's total of \$3.3b.
- Total of 52 transactions, average size of \$82.95m.
- Total funds raised in July 2022 for Energy & Minerals was \$0.6b.
- Total of 36 Energy & Minerals transactions, average size of \$17.78m




