

December 2022 - Overview

- ASX-listed companies raised \$1.2bn across 85 transactions in December 2022
- Represents a 92% decrease vs December 2021's total of \$14,992.4bn, and a 5% decrease vs November 2022's total of \$1.3bn.
- December's average deal size was \$14.1m.
- Total funds raised in December 2022 for Energy & Minerals was \$902.7m
- Total of 64 Energy & Minerals transactions, average size of \$14.1m
- The top 5 ECM transactions in December were:
 - 1. Genesis Minerals \$275m Placement
 - 2. Domino's Pizza \$153m Placement
 - 3. Arafura Rare Earths \$121m Placement
 - 4. Regal Investment Fund \$80m Placement
 - 5. Renascor Resources \$70m Placement

YEAR TO DATE


- ASX- listed companies raised \$27.5bn in the twelve months to 31 December 2022
- Represents a 50% decrease from 2021 comparable period of A\$54.9bn.
- Total of 894 transactions vs 1,250 in the comparable period last year (28% decrease).
- The number of Initial Public Offerings decreased by 51% over the 2022 period in comparison to 2021.








ECM Activity Breakdown
