### December Quarter 2023 - Overview


- ASX-listed companies raised \$5.7bn across 243 transactions between 1 October and 31 December 2023.
- Represents a 75% increase vs December 2022 Quarter (\$3.3bn).
- The quarter's average deal size was \$23.4m.
- Total funds raised in the quarter for Energy & Minerals was \$2.8bn
- Total of 155 Energy & Minerals transactions, average size of \$13.3m
- The top 5 ECM transactions in the quarter were:
  - 1. Treasury Wine Estates \$825m Rights
  - 2. Evolution Mining \$525m Placement
  - 3. Karoon Energy- \$480m Placement and Rights
  - 4. Sigma Healthcare \$400m Rights
  - 5. Liontown Resources \$400m Placement



## Steady ECM volumes for 2023 not indicative of ongoing volatility





ECM Volume, December 23' Quarter, \$5.5bn




ECM Volume, December 22' Quarter, \$3.3bn


### December Quarter 23' ECM Transactions, Visualised
